

The regular meeting of the City Council was held in the Municipal Court Room on June 18, 1969 at 7:30 p.m. with Mayor Flanary presiding.

Present: V. O. Flanary, G. E. Hunnicutt, R. L. Collins, S. H. Neeley, W. G. Stallard

Also Present: Evan Norton, City Manager and Robert Stump, Leslie Mullins, Attorney

Minutes of the previous meeting were read and approved.

Mr. James Peters appeared before Council regarding bill for water line at Mrs. E. W. Poston's residence. Matter referred to City Manager. 4870

A group of people from Davis Chapel Church with Paul Leonard as spokesman appeared before Council requesting sewer extension to their church on Kentucky Avenue. Matter referred to City Manager for further investigation. 4871

Coach Gilliam appeared before Council regarding swimming pool for colored children on Kentucky Avenue. Council discussed this matter briefly. No definite action taken. Council also discussed track field. 4872

Mr. Phil Gross and Mr. Kanto, representatives of Duffield Industrial Development Authority appeared before Council requesting that one-third of the City's budgeted appropriation be paid before July 30th in order to settle land options. 4873

On motion by S. H. Neeley, seconded by R. L. Collins and carried by unanimous roll call vote, Council moved that the City pay Industrial Development Authority of Lee, Scott, Wise Counties and City of Norton $\frac{1}{3}$ of the amount agreed upon or \$5,845.00 if and when LENOWISCO satisfies Mr. Norton that other three sub-divisions have come up with their appropriations and EDA grant has been obtained. 4874

Mr. Gross stated that the Chairman of the Authority asked that he express their gratitude to Mr. Stump for the legal work he had done for the Authority. 4875

Mr. Norton advised Council of the Highway allocations meeting to be held in Roanoke, June 19th. 4876

Mr. Norton presented letter from LENOWISCO regarding status of various projects. 4877

Mr. Norton advised Council of a meeting to be held in Richmond in July on the ninth to go over the Workable Program and other projects with HUD Representatives from Philadelphia office. 4878

Mr. Norton advised Council that bids for Kentucky Avenue project would be opened July 25th. 4879

The City Manager advised Council of letter received from Mr. Russell of TV Cable Service regarding status of TV Cable Service. 4880

Mr. Norton reported on status of Highway project on Route #74. 4881

Mr. Norton presented request of Ralph Blevins to purchase lot belonging to City on West Norton Road near Viaduct. No action taken. 4882


Mr. Norton reported on trip to Richmond on June 16th & 17th. 4883
