Mr. Norton presented concession agreement with C. & P. Telephone Company.
On motion by S.H. Neeley, seconded by W.G. Stallard and carried by unanimous vote council moved that the following concession service agreement with C. & P. Telephone Company be approved:

THIS AGREEMENT, made this 2nd day of December A.D., 1969, by and between the Chesapeake and Potomac Telephone Company of Virginia, hereinafter called "COMPANY" party of the first part, and the CITY OF NORTON, Wise County, Virginia, acting by its Mayor and Council, hereinafter called "CITY", party of the second part.

WITNESSETH: That in consideration of the enactment by "City of an ordinance on the 2nd day of December, A.D., 1969, granting permission to the Chesapeake and Potomac Telephone Company of Virginia, its successors and assigns, to construct, maintain and operate its posts, poles, conduits, manholes, ducts, cables, wires and all other necessary overhead and underground apparatus on, over, along, in, under and through the streets, alleys, highways and other public places within the limits of the City of Norton, in the County of Wise, and State of Virginia; and to use the property of other companies and permit other companies to use its sroperty upon such arrangements as the two companies may agree; "Company" hereby agrees to provide and maintain for the "City" a minimum of five (5) free telephones for unlimited local exchange service, plus one such additional telephone for each additional 500 telephone stations above 2250 within the corporate limits of said city, or other local exhange services of a monthly revenue va equal thereto, to be located at such locations along its lines within the corporate limits of the said City as the "City" may direct.

This agreement shall continue in force as long as "Company" its successors and assigns, enjoys the rights and privileges granted in the aforesaid ordinance.

IN WITNESS WHEREOF, the parties hereto have caused these presents to be properly executed the day and year first above written.

Resolved that the Norton City Council at its regular meeting of December 2, 1969 authorized the City Manager to sign and execute on behalf of the City an agreement with the Virginia Department of Highways concerning the construction of Kentucky 5018 Avenue entitled "Agreement By Municipality or Political Subdivision To Maintain Highways Improved Under Provisions of Federal Highway Act As Amended And Supplemented."

Mr. Norton advised council that a meeting with Board of Assessors would be held Wednesday, December 3rd in City Hall at 1:00 P.M.

Mr. Norton advised council that the Commissioner of Revenue was working on delinquent tax list in line with getting current owners.

Mr. Daniels and Mr. Norton discussed with Council operation of Coke Ovens. Council was advised that the City Code specified six months and the State Code specified two years as the time limit beyond which a non-conforming use cannot be legally re-activated after deactivation for those periods. This was to advise the Council that the required time limits had probably elapsed and that steps whould be taken to prevent re-activation if efforts whould be made to do so.
