

The regular meeting of the City Council was held in the Municipal Court Room on July 2, 1968, at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, G.E. Hunnicutt, C.W. Bryant, S.H. Neeley

Also Present: David Norman, City Manager & Leslie Mullins, Robert Stump, Attorneys

Absent: R.L. Collins

Minutes of the previous meeting were read and approved.

Council discussed at length with Mr. Hershel Bowers cost estimate on pump for Nosler Circle. #4431

Carroll Tate appeared before council and expressed his appreciation for the fine cooperation and assistance he had received from Mr. Norman during his managership. #4432

Carroll Tate, as chairman of Norton Industrial Development Authority, reported on progress and activities of the Authority.

Mr. Tate also commended Mayor Flanary on his progress at the Flag Rock. #4433

Mr. Norman advised council of his findings on paving of the library parking lot. Matter tabled. #4434

On motion by C.W. Bryant, seconded by S.H. Neeley and carried by unanimous vote, Linville Reed was appointed as member of Zoning Appeal Board to fill term of N.H. Shell, said term to expire June 30, 1970. #4435

On motion by C.W. Bryant, seconded by S.H. Neeley and carried by unanimous vote, council moved that Hugh Cline be reappointed as member of City of Norton School Board for three year term, said term to expire June 30, 1971. #4436

Mr. Norman discussed with council briefly Highway Safety Legislation. Action on matter was tabled until further study by the Chief of Police. #4437

Attorney Mullins advised council that he had arranged a meeting with concerned property owners for discussion of housing development for City of Norton, said meeting to be held Tuesday night, July 9. #4438

On motion by S.H. Neeley, seconded by V.O. Flanary and carried by unanimous vote, council moved that the above matter be studied and investigated to its fullest depths. #4439

Mr. Norman presented letter regarding Community College. Matter referred to W.P. Kanto for his advice. #4440

Mr. Norman advised council of the street lighting on southside as per request of previous meeting. #4441

On motion by S.H. Neeley, seconded by G.E. Hunnicutt and carried by unanimous roll call vote, council moved that two street lights be installed, one on 4th St. and one on 3rd St. at intersection of alley as per recommendation of the City Manager.

Mr. Norman advised council that paving bids are scheduled to be opened July 12. #4442

Mr. Norman advised that Mr. Hamner agreed to follow up with right of wayoon Hamner Avenue for street paving.

Mr. Norman advised council of right of way payment of \$4,130.00 for Kentucky Avenue.

Mr. Norman presented street light request for Riddle Street.

On motion by S.H. Neeley, seconded by C.W. Bryant and carried by unanimous roll call vote, council moved that street light be installed on Riddle Street as per recommendation of City Manager.

Mr. Norman advised council of delivery of fire truck and of the exclusive showing to be at 7:00 P.M., Tuesday, July 9.

Mr. Norman presented sales tax collections during year 1967-68.

On motion by S.H. Neeley, seconded by C.W. Bryant and carried by unanimous vote, Mayor V.O. Flanary was authorized to sign checks for city of Norton in absence of City Manager.

The City Attorney was instructed to draw up resolution commending City Manager for a job well done.

Mr. Norman presented letter to council expressing his appreciation for the fine cooperation he had received from council and City of Norton during his tenure of office here.

Mayor Flanary presented letter requesting law being enforced regarding having horses in the City of Norton. Matter referred to city attorney for next council meeting.
