

The regular meeting of the City Council was held in the Municipal Court Room on August 17, 1965 at 7:30 P.M. with Mayor Holcomb presiding.

Present: J.C. Holcomb, V.O. Flanary, C.W. Bryant, R.L. Collins

Absent: Archie Woods

Also Present: David Norman, City Manager and R.T. Winston, Attorney

Minutes of the previous meeting were read and approved.

Mr. Winston advised council of his findings regarding property on which the swimming pool is located. He stated that in 1959 the Norfolk & Western Railway Company had conveyed five tracts of land to City of Norton, said tracts of land to be used for public purposes. 2493

On motion by C.W. Bryant, seconded by R.L. Collins and carried by unanimous vote the following resolution was passed:

BE IT RESOLVED by the Council of the City of Norton that Clarence Holcomb Mayor, be, and he hereby is, authorized to execute on behalf of the City of Norton that certain lease agreement dated July 27, 1965, between the Louisville & Nashville Railroad Company and the City of Norton, a copy of said lease being hereto attached and made a part of this resolution. 2494

(Lease filed in vault with other deeds, leases)

On motion made and duly seconded council moved that a Labor Day Banner be placed across Park Avenue. 2495

On motion by C.W. Bryant, seconded by V.O. Flanary and carried by unanimous vote the following Truancy Ordinance was passed: 2496

Mayor Holcomb presented request of City of Norton School Board for appointment of City Sergeant as truant officer. Council agreed to leave this appointment to Chief of Police and City Manager. 2497

 Mayor Holcomb gave report of delinquent taxes for 1st 16 days of August - taxes \$2,046.54; penalty & interest \$106.99 or a total of \$2,153.53 for 1st 16 days. 2498

Mr. Norman presented treasurer's report for month of July, 1965.

Mr. Norman advised council of the status of the Chestnut Street wall in front of Witts and Fraleys. A brief discussion was held after which it was decided that Mr. Norman would talk with Mrs. Fraley before any further work is done on the wall. 2499

Mr. Norman advised council that he had located the bonding company for the roof on the Municipal building and that a representative would be in the near future to discuss this matter. 2500

Mr. Norman advised council that since the alley behind Coalfield Progress Building and Western Auto Store had been opened there are spaces for six additional parking meters. He stated that the owners of the buildings were in agreement for the placing of these meters. Council expressed their approval for the installation of these meters. 2501

Mr. Norman advised council that soda ash had not been placed in the water as yet due to the repair of the city's present lime machine.

Mr. Norman advised council that the leak survey equipment owned by the city is very defective, therefore, new equipment would have to be purchased or a survey be made by Pitometer meter survey company.


Mr. Norman presented a memorandum to council regarding regulations regarding the subdivision of land. Mr. Jones & Mr. Cooper were present discussing with council their new subdivision on Whitaker's farm. After a lengthy discussion council instructed the city manager to check into the kind of water supply needed for this subdivision as to size of lines, kind & size of water tanks, pumps, and cost of same. Council advised Mr. Jones & Mr. Cooper to check with Health Department regarding sewer lines.


