

July 7, 1964

The regular meeting of the City Council was held in the Municipal Court Room on July 7, 1964 at 7:30 P.M. with Mayor B.E. Ball presiding.

Minutes of the previous meetings were read and approved.

On motion by J.C. Holcomb, seconded by Archie Woods and carried by unanimous roll call vote, the following ordinance was passed:

#2780

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTON that pursuant to Section 8825.1 of the Code of Virginia, that the Council of the City of Norton as the governing body of said City, hereby designates as a storage area under said law the sheds at the City Shop located in the City of Norton, Virginia.

An emergency existing, this ordinance shall be in effect as of 7th day of July, 1964.

On motion by A.O. Umstead, seconded by Archie Woods and carried by unanimous roll call vote, the following ordinance regarding drunken driving and blood tests was passed:

On motion by Archie Woods, seconded by J.C. Holcomb and carried by unanimous #2782 vote, the following resolution was passed:

BE IT RESOLVED by the Council of the City of Norton that, whereas J.J. Stump, Sr., has completed his current term of service on the City of Norton School Board and has served many years on our School Board, and whereas Mr. Stump's service on the School Board has been marked by diligent and conscientious effort and the City has received the great benefit of Mr. Stump's experience, judgment and effort.

NOW, THEREFORE, BE IT RESOLVED that the Council extends its sincere appreciation of Mr. Stump's work and services on the City School Board, and that we gratefully acknowledge his accomplishments toward the progress of our City.

On motion by J.C. Holcomb, seconded by Archie Woods and carried by unanimous #2783 roll call vote, the following resolution was passed:

RESOLVED that the City Manager be directed to request the State Highway Department to begin to give immediate consideration to formulating plans for the relocation and reconstruction of State Route 74 within the City of Norton.

BE IT FURTHER RESOLVED that the City of Norton agrees to participate by 15% in the total project cost.

On motion by Archie Woods, seconded by J.C. Holcomb and carried by unanimous #2784 vote, permission was granted for the issuance of a taxi driver's permit to Willie J.R. McFall, said driver to operate from 96 Cab Company.

On motion by Archie Woods, seconded by J.C. Holcomb and carried by unanimous #2785 roll call vote, council instructed the City Manager to have the Old Dominion Power Company install a street light on 6th Street, S.W. at intersection of alley between Ky. Ave. and Roberts Ave.

Mr. Jester gave report of delinquent taxes for month of June, 1964: #2786
Taxes = \$697.59; penalty & interest \$302.61; Total \$1,000.20, making a total for the year of \$22,367.17.

Mr. Jester gave the fire report for the month of June, 1964. There were three #2787 fire calls during the month.

Mr. Jester presented request of Mrs. Halloway of the Chamber of Commerce for #2788 the City to buy a membership in the Chamber of Commerce.

On motion by A.O. Umstead, seconded by J.C. Holcomb and carried by unanimous vote, council moved that the City purchase one subscription at \$25.00, as requested.

On motion by J.C. Holcomb, seconded by Archie Woods and carried by unanimous #2789 roll call vote, the following resolution was passed:

WHEREAS, Mr. H.G. Dalton has departed this life after many years of faithful service to this City and community

BE IT THEREFORE RESOLVED that this council note with regret Mr. Dalton's passing, that we extend deepest sympathy to Mrs. Dalton and the family in their loss, THAT we note with appreciation the splendid work and service rendered by Mr. Dalton to the City in his capacity as Commissioner of Revenue and that we gratefully acknowledge Mr. Dalton's accomplishments as a citizen and as one who has contributed much to the growth and life of our community, and

THAT a copy of this resolution be sent to Mrs. H.G. Dalton.
