

October 15, 1963

The regular meeting of the City Council was held in the Municipal Court Room on October 15, 1963, at 7:30 P.M. with Mayor B.E. Ball presiding.

Present: B.E. Ball, J.C. Holcomb, Archie Woods

Absent: A.O. Umstead, J.B. Taggart

Also Present: C.F. Jester, Jr., City Manager & R.T. Winston, Attorney

Minutes of the previous meeting were read and approved.

Mr. Jester advised council that a thirty day extension for starting construction on the sewer project had been granted. The new deadline is November 4th. #2545

Mr. Jester read to council a letter from Mr. Lindsey of Hayes, Seay, Mattern & Mattern regarding Benges Branch treatment plant. The City Manager was instructed to keep council up to date on this matter. #2546

Mr. Jester gave a report of delinquent tax collections and delinquent accounts for first fifteen days of October. #2547

Mr. Jester presented the Treasurer's report for month of September, 1963 #2548

Mr. Jester advised council of the water level in the dam. #2549

Mr. Jester advised council of his conference with the TV Cable Service representative. #2550

On motion by J.C. Holcomb, seconded by Archie Woods and carried by unanimous vote, the following resolution was passed: #2551

A RESOLUTION OF THE COUNCIL OF THE CITY OF NORTON, VIRGINIA:"

Whereas, the City Council of Norton, Virginia, recognized the past accomplishments and continual growth of Clinch Valley College with appreciation.

Whereas, the Council believes the continual growth of Clinch Valley College can be best nourished by providing living quarters on the campus for the growing enrollment of which many students must commute many miles daily over rough roads.

Whereas, such living quarters on the campus would make the school library available to more students, as well as improve the crowded study conditions many students are now experiencing in their homes.

Now, Therefore, Be It Resolved, that the University of Virginia, Be, and it is, hereby respectfully requested to consider the building of additional dormitories to answer the present demand, to insure continual growth, to reduce the number of required commuters, and to be of better service to the community. Additional dormitories should be provided concurrently with additional class room facilities.

Mr. Jester discussed with council the possibility of having parallel parking from 5th Street and Park Avenue to corner at Holcomb's Esso Station and from 9th to 10th Street. Council was in agreement with this suggestion. #2552

Mr. Jester presented to council request of Mr. B.C. All to #2553
pave alley back of his residence in order to eliminate dust.
Request denied.

Mr. Jester advised council that bids had been received for #2554
a new police car. He also advised council that gasoline bids
would be received on November 1st at 2:00 P.M.


Mr. Jester presented to council the possibility of a #2555
