Mr. Ward opened the floor for the nominations of Mayor.

Joseph Hunnicutt nominated Robert Raines to be reappointed as Mayor.

Upon a motion by Joseph Fawbush, seconded by Joseph Hunnicutt, and passed by unanimous vote, Council moved that the nominations cease.


