

The regular meeting of the City Council was held in the Municipal Council Chambers on April 7, 1987 at 7:30 P.M. with Mayor Daniels presiding.

Invocation was given by Vice Mayor Raines, followed with Pledge of Allegiance led by Mrs. Clements. 13774

On motion by William Mays, seconded by Jack Wallace and carried by unanimous vote, Council moved that minutes of regular meeting of March 17, 1987 be approved as presented. 13775

On motion by Roy Roberts, seconded by William Mays and carried by unanimous vote, Council moved that minutes of April 1, 1987 be approved as presented. 13776

Confirmation of a check in the amount of \$150,000.00 to the City of Norton Schools. On motion by Jack Wallace, seconded by Roy Roberts and carried by unanimous vote, Council moved that check in the amount of \$150,000.00 to City of Norton Schools be approved. 13777

Confirmation of a check in the amount of \$115,797.46 to Cherokee Construction Co. On motion by Roy Roberts, seconded by Jack Wallace and carried by unanimous vote, Council moved that check in amount of \$115,797.46 to Chereokee Construction Company be approved. 13778

Discussion of House Bill 1605 and the Possibility of Appointing a Local Health Services Advisory Board. Mr. Brown addressed this subject. Council briefly discussed this matter. Council instructed the City Manager to bring this matter back at such time when more information is received. 13779

Confirmation of selection of an Assessor as Per the advertised request for proposal. Mr. Brown addressed this subject. Council discussed the matter briefly. 13780 On motion by Roy Roberts, seconded by William Mays and carried by unanimous roll call vote, Council moved to accept proposal by Frank Stacy to do re-assessing of all real property in City of Norton.

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous vote, Council moved they go into executive session to discuss Personnel Matters as Per 2.1-344 (A) (1) of the Code of Virginia, as Amended and Legal Matter as Per 2.1-344 (A) (6) of the Code of Virginia as Amended. 13781

On motion by Robert Raines, seconded by William Mays and carried by unanimous vote, Council moved to go back into regular session. The Mayor declared council back in regular session. The Mayor advised that in regard to legal they only received some up-dates and are not prepared to make any disclosure at this point. 13782 In regard to appointments, they will be placed on the next council meeting agenda.

Comments by the City Manager - The City Manager stated he would like to publicly compliment the City Crews on good work they had done during the snow. The Mayor in behalf of council echoed the same compliments as the City Manager. 13783
