

The regular meeting of the City Council was held in the Municipal Building on January 21, 1986 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: Roy Roberts, Robert Raines, George Hunnicutt, Milas Franks, Cliff Daniels

Invocation was given by the Rev. Spencer Price.

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous vote, Council moved that minutes of Jan. 7, 1986 be approved as presented. 13365

On Motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that minutes of continued meeting of Jan. 13, 1986 be approved as presented. 13366

Public Hearing to Re-Zone Certain BoCo Property from R-B (Multi-Family) to R-A (Single Family).

Council briefly discussed this request which was unanimously approved by the City of Norton Planning Commission.

On motion by Milas Franks, seconded by Roy Roberts and carried by unanimous vote, Council moved that "An Ordinance of the City Council of the City of Norton Virginia, rezoning certain Boco Property from an RB Multi-Family Classification to an RA Single Family Classification" as presented for our consideration be passed on first reading. 13367

Public Hearing on Request by the City of Norton School Board to Apply for three (3) Literary Loans to Make Permanent Improvements to the Elementary and High Schools.

Mr. Armenttrout, Supt. of Schools, Addressed this subject, giving the different projects which these loans were to cover.

Council briefly discussed this matter.

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous roll call vote, the following resolution was passed: 13368

Resolved, that the Application of the City School Board to the State Board of Education of Virginia for a loan of \$310,000.00, \$125,000.00, \$30,000.00 from the Literary Fund is hereby approved, and authority is hereby granted the said City School Board to borrow the said amount for the purpose set out in said application, as per attached inserts.

Council briefly discussed this matter.

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous vote, Council moved that a "Resolution of the City Council of the City of Norton, Virginia Adopting and Approving a Wage and Salary Classification Program and Policies and Procedures for Administration Thereof and Establishing an Effective Date of January 1, 1986, making it retroactive to Jan. 1, 1986, be passed. 13369
