

The regular meeting of the City Council was held in the Municipal Court Room on July 1, 1986 at 7:30 P.M. with Mayor Daniels presiding.

Present: Roy Roberts, Robert Raines, Cliff Daniels, Milas Franks, William Mays

Also Present: C.R. Brown, City Manager

Absent: Kenneth Asbury, City Attorney

The invocation was given by Rev. Warren Stewart, followed with his leading in the Pledge of Allegiance. 13511

Mayor Daniels gave a few brief opening remarks. 13512

On motion by Robert Raines, seconded by Roy Roberts and carried by unanimous vote, Council moved that minutes of June 17, 1986 be approved as presented. 13513

On motion by Milas Franks, seconded by Robert Raines and carried by unanimous vote, Council moved that special called meeting minutes of June 26, 1986 be approved as presented. 13514

Mr. Brown, City Manager, presented a very informative water report status, Mayor Daniels briefly commented on Mr. Brown's report. 13515

The Mayor called upon the citizens from East Norton, who wished to address the subject of Wise Water in their system. Mr. David Jones of 210-7th Street presented a petition to council and addressed questions which the group wanted answered. Mayor Daniels answered the questions as presented. 13516

On motion by Milas Franks, seconded by Roy Roberts and carried by unanimous vote, Council moved that confirm the check to Norton School Board in the amount of \$138,387.84. 13517

Request permission to Proceed with bids for water system Improvements.

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous vote, Council moved that authorize the City Manager to advertise for bids the Norton Water Improvement Project at earliest possible time that it is ready thru the engineers. 13518

The Mayor pointed out that council should be aware that the Revenue Sharing Budget was such that it could be changed if some unforeseen item come up.

Discussion of Proposed E-911 Ordinance Prior to a Public Hearing. Mr. Brown brought council up-to-date on this ordinance, Council discussed this ordinance briefly. Councilman Roberts abstained from any discussion or voting on this matter. Since this matter was for discussion only - no action taken. 13519

On motion by Roy Roberts, seconded by Robert Raines and carried by unanimous vote, Council moved they go into executive session to discuss personnel as Per 2,1-344 (A) (1) of the Code of Virginia, as Amended and Legal Matters as Per 2,1-344 (A) (6) of the Code of Virginia, as Amended. 13520

On motion by Robert Raines, seconded by Roy Roberts and carried by unanimous vote, Council moved they go back into regular session. The Mayor declared council back in regular session. 13521
The Mayor advised there was no report to make concerning legal matters.

Appointment to Norton Planning Commission held over until next council meeting.
The Mayor advised it was the concensus of the Council that no appointment should be made on the first time placed on an agenda.

William Mays nominated Ron McCall to Norton-Wise Regional Waste Water Treatment Authority for initial term to 5-15-87.

On motion by Milas Franks, seconded by Roy Roberts and carried by unanimous vote, Council moved the nominations be closed.

The Mayor declared Ron McCall appointed to Norton-Wise Regional Waste Water Treatment Authority for period ending 5-15-87.


