

The regular meeting of the City Council was held in the Municipal Court Room on September 17, 1985 at 7:30 P.M. with Mayor Hunnicutt presiding.

Invocation was given by Rev. James M. Wells

On motion by Milas Franks; seconded by Cliff Daniels and carried by unanimous vote, Council moved that minutes of Sept. 3, 1985 be approved as presented. 13279

Public Hearing on "An Ordinance Amending the Zoning Ordinance of the City of Norton to include Conditional Zoning, as Per 15.1-491.1 of the Code of Virginia, as amended.

The City Manager explained this proposed ordinance.

Mr. Robert Raines of the audience spoke on this matter. Council discussed this matter at length. 13280

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous vote, Council moved that this ordinance be tabled for further study.

Consideration of a New Consent Decree, between the City of Norton, The Town of Wise, and the State Water Control Board.

The City Manager addressed this subject briefly after which the council discussed the matter. 13281

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved that table this matter until a later date for further study.

Request to sell the Wise PSA more Water, on a Exchange Basis when needed to supply families in the Needmore Area.

Council discussed this matter at length.

On motion by Milas Franks, seconded by Cliff Daniels and carried by the following votes, Roberts, NO; Hunnicutt, Franks, Daniels, YES, Council moved that PSA be authorized to extend water line to seven or nine families in need of water in Needmore area with the express limitation there will be no further extensions unless process in same manner of approval by City Council as in agreement prepared by City Manager and City Attorney. 13282

Request to Participate in the Housing Voucher Program, through the Public Housing Agency, in Accordance with our existing housing assistance plan.

Mr. Brown briefed council on this matter. 13283

Council discussed this matter briefly. Council requested this matter be tabled until next meeting.

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved they go into executive session to discuss personnel, as Per 2.1-344 (A) (1) of the Code of Virginia, as Amended. 13284

On motion by Cliff Daniels, seconded by Milas Franks and carried by unanimous vote, Council moved they go back into regular session.

The Mayor declared council back in regular session.

The Mayor announced they regret they are unable to name the other member of council at this time. 13285

The Mayor asked that City Attorney write up a resolution in commemoration of our departed member, Ray Salyers, to be signed by all members of the Council. 13286

Appointment to Sub-area Health Council.

Milas Franks nominated Rev. Parrish Jones for reappointment to Sub-area Health Council for three year period ending 10-31-88.

Cliff Daniels moved, seconded by Roy Roberts that nominations be closed.


The Mayor declared Rev. Parrish Jones elected by acclamation, said term to expire October 31, 1988.
