

The regular meeting of the City Council was held in the Municipal Court Room on January 3, 1984 at 7:30 P.M. with Mayor Hunnicutt presiding.

Invocation by the Rev. Claude D. Quillen

On motion by Roy Roberts, seconded by Cliff Daniels and carried by unanimous vote, Council moved that the minutes of December 20th be approved as presented and corrected.

Special presentation by Dr. Victor B. Ficker, President of Mountain Empire Community College. Dr. Ficker presented each councilman with an Annual Report of the Mountain Empire Community College and requested a proclamation designating the fourth week of January as Community College week.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved that fourth week in January be designated as Community College Week.

The Mayor announced at this time they would have the public hearing on "An Ordinance of the City Council of the City of Norton, Virginia Reappropriating the \$68,322.44 Surplus Plus Appropriating \$12,039.76 Interest in the City School Fund to the School Board of the City of Norton, Virginia.

Dr. Culbertson discussed this matter briefly with Council and advised them of the ways they hoped to spend these funds.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous roll call vote, Council moved that the following Ordinance of the City Council of the City of Norton, Virginia, Reappropriating the \$68,322.44 Surplus Plus Appropriating \$12,039.76 interest in the City School Fund to the School Board of the City of Norton, Virginia be passed on first reading.

An Ordinance making it Unlawful for a Vehicle Not Displaying a License Plate, Decal or Special Parking Permit to be Parked in a Parking Space Reserved for the Handicapped on Public or Private Property.

On motion by Roy Roberts, seconded by W.F. McElroy and carried by unanimous vote, Council moved that "An Ordinance Making It Unlawful for a Vehicle Not Displaying a License Plate, Decal or Special Parking Permit to be parked in a Parking Space Reserved for the Handicapped on Public or Private Property be passed on second reading.

Discussion of Water Reserves - Council briefly discussed this matter. The City Manager brought them up-to-date on water, advising the status of Robinette Branch.

Discussion of Requested joint meeting with the Planning Commission to review the Proposed Site Plan Ordinance. Matter tabled until next council meeting.

The City Manager advised council that he had appointed Captain Bruce Rose as Acting Chief of Police until such time a chief is appointed.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that go into Executive Session to discuss personnel as Per 2.1-344 (A) (1) of the Code of Virginia, As Amended.

On motion by Vic Jones, seconded by Cliff Daniels and carried by unanimous vote, Council moved they go back into regular session.

11105

The Mayor declared council back in regular session.

The Mayor advised that once again council had considered a list to reconstitute Joint Housing Appeals and Uniform Standards Board. He advised that all the persons had not been contacted and they hoped to be able to reconstitute this board at January 17th meeting. The Mayor advised there was no conclusion as yet on appointment to N.R. & H.A. since all information requested had not been received but was advised this would be forthcoming in time for appointment at Jan. 17th Meeting.


Councilman Jones brought up matter of two hour parking. Council briefly discussed this matter and referred it to City Manager for action.
