Milas Franks moved nominations be closed, seconded by Ray Salyers and carried by unanimous vote. The Mayor declared Cliff Daniels elected by Acclamation. 11282

Cliff Daniels nominated Jo Nosler as Clerk of Council and Mary Brown as Alternate.

On motion by Roy Roberts, seconded by Ray Salyers and carried by unanimous vote, Council moved the nominations be closed. The Mayor declared Jo Nosler as Clerk of Council and Mary Brown as Alternate. 11283

Appointment of City Attorney as Per 3.923 of the City Charter.

Milas Franks nominated Kenneth Asbury as City Attorney.

On motion by Cliff Daniels, seconded by Roy Roberts and carried by unanimous vote, Council moved the nominations be closed. Mayor declared Kenneth Asbury appointed City Attorney. 11284

Appointment of City Manager as Per 3.906 of the City Charter.

Cliff Daniels nominated Charles R. Brown as City Manager




