

The regular meeting of the City Council was held in the Municipal Court Room on October 20, 1981 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: George Hunnicutt, W.F. McElroy, Robert Collier, Cliff Daniels, Vic Jones

Also Present: G.M. Newman, City Manager & Kenneth Asbury, Attorney

On motion by W.F. McElroy, seconded by Robert Collier and carried by unanimous vote, Council moved that minutes of Public Hearing Revenue Sharing Budget and minutes of October 6, 1981 be approved as presented.

Mr. Mike Jackson of Countiss Avenue appeared before council regarding his water bill. He discussed at length with council the change of his meter - he was of the opinion the correct reading was not recorded at time of change of meter. After the discussion, Council ask that the City Manager check this matter out.

Councilman Jones presented approaches for revitalization of the Central Business district. Council discussed this plan at length with Mr. Jones. He also presented an ordinance which was carried over until next council meeting for consideration. Council was in agreement with the plans of Councilman Jones.

On motion by W.F. McElroy, seconded by Vic Jones and carried by unanimous roll call vote, Council moved that City Manager be authorized to purchase a salt-spreader at cost of \$4,453.25, said funds to come out of capital outlay.

On motion by W.F. McElroy, seconded by Robert Collier and carried by unanimous vote, Council moved that they go into executive session to discuss pending litigation and use of real property for public purposes.

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, Council moved they go back into regular session.

Mayor Hunnicutt declared council back in regular session.

Mayor Hunnicutt announced that as to possible pending litigation no conclusion on litigation at the present time. As to use of real property for public purposes, council authorized and directed the City Manager to call upon Mr. Caraylannis, Director of Wise County and City of Norton U.M.C.A. to make arrangements to make an accounting and give us a balance sheet, bring rental payments up-to-date for use of facilities, make available for City of Norton recreation office space in the building, clear all recreation activities thru City of Norton Recreation Department.

The City Manager advised council the street sweeper was in need of repair. The cost to be approximately \$5,000.00.

Mr. Newman reported on meeting with Wiley & Wilson regarding Clear Creek Water Project. He advised the engineers were recommending that City go with package treatment plant on Clear Creek Site. Mayor Hunnicutt brought to council's attention the property of Industrial Development Authority and Bd. of Supervisors being involved in this deal. Council ask that the City Manager or City Attorney contact the two entities regarding their property being involved.


Mayor Hunnicutt ask the City Attorney if he had gotten any more information on water & sewer easements. Council discussed this matter briefly.
