

The regular meeting of the City Council was held in the Municipal Court Room on July 1, 1980 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: George Hunnicutt, W.F. McElroy, Robert Collier, Cliff Daniels, Vic Jones

Also Present: G.M. Newman, City Manager & Kenneth Asbury, Attorney

Minutes of the previous meeting were approved as presented.

Council briefly discussed ordinance "Regulating Public Parking Lots" and tabled matter until next council meeting until City Attorney consults with Fire Marshall regarding same.

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous roll call vote, Council moved that the following ordinance "Creating an Auxillary Police Force and Providing for Implementation and Appointment thereof: with limit of ten in Section 1 be passed. (Insert)

Council discussed at length lease of Old Norton Community Hospital Property for parking. On motion by W.F. McElroy, seconded by Vic Jones and carried by the following votes, Hunnicutt, McElroy, Collier, Jones, YES; Daniels, No, Council moved that the City Manager be authorized and directed to request use of Hospital Property for parking lot on temporary basis to be leased for \$1.00 per year for day time parking only, subject to forty-eight hour cancellation.

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, Council moved they go into executive session to consider personnel matter.

On motion by W.F. McElroy, seconded by Cliff Daniels and carried by unanimous vote, Council moved that go back into regular session.

Mayor Hunnicutt declared council back in regular session.

Robert Collier nominated Virginia Horne to fill the unexpired term of James Dotson on City of Norton Welfare Board.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that nominations be closed.

Mayor Hunnicutt declared Virginia Horne appointed to City of Norton Welfare Board to fill the unexpired term of Jim Dotson, said term to expire Nov. 21, 1982.

Mr. Newman presented request for an appropriation out of Community Development Funds for \$2500.00 to purchase a riding lawn mower.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous roll call vote, Council moved that the City Manager be authorized and directed to spend \$2500.00 out of C.D.B.G. entitlement Fund to purchase a riding lawn mower.

Councilman Daniels ask that up-date on entitlement funds be made.

Mr. Newman discussed with council the picking up of 10" line extending from Black Diamond from end of Highway Project to Elementary School entrance at East Park Avenue. Council discussed this matter briefly.

Mr. Newman discussed with Council the possibilities for different sources of water supply. He advised that Clear Creek has more water than any other stream around. After a discussion of this matter council ask that the City Manager get more data and report back to council at July 15th meeting.


Councilman Jones suggested that City remove parking meters in downtown section and also have angle parking. He presented the different pros and cons of the matter. Council discussed this matter with reference to traffic lights as relates to flow of traffic.

Councilman Collier brought to council's att ention the hazard of street at corner of Burton High School and State Police Office when wet. Council discussed this matter briefly and ask that the City Manager check into this matter to see what could be done.
