McElroy, Yes, George Hunnicutt, Yes, Roy Roberts, Yes, Vernon Flanary, Yes) council moved to approve the redevelopment plan for the Southside Urban Renewal Area, No. 1, Community Development Program as amended by Amendment No. 4, "Page 9, No. 3, Timed Regulations to be in effect.

The above regulations and land use provisions, including any amendments thereto, shall be in full force and effect until June 30, 1994."
