

The regular meeting of the City Council was held in the Municipal Court Room on October 7, 1975 at 7:30 P.M. with Mayor Fulks presiding.

Minutes of the September 2nd meeting were read and approved as read.

Minutes of September 3rd special meeting were read and approved with correction of \$6,200 in place of \$2,650.

Minutes of special meeting of September 9th were read and approved.

Mr. Bruce Funk of the Flatwoods Section of Coeburn appeared before Council asking support of City Council in getting felony cases moved from Camp 18 in the Flatwoods area of Coeburn. 7208

On motion by Jim Humphreys, seconded by Roy Roberts and carried by unanimous roll call vote Council moved to instruct the City Manager to advise the Concerned Citizens of the Commonwealth Committee that the City of Norton supports the activities and objectives of their committee in regard to their efforts of removing felony criminals from Camp 18 and further supports their suggestion for interim measures to assure that these felony criminals are properly identifiable and under proper supervision at all times.

Mr. Brainard Mullins appeared before the Council requesting an additional taxi cab, Yellow Top Cab. (Petition attached)Page 195). 7209

On motion by Jim Humphreys, seconded by Roy Roberts and carried by unanimous roll call vote Council authorized the City Manager to study cab situation in the City of Norton and if he sees need for additional cabs, draw up an ordinance for additional cabs. Ike Fulks, yes; Roy Roberts, Yes; Jim Humphreys, yes.

Mr. George Scott appeared before Council regarding the dirty condition of the City of Norton. Council discussed this with Mr. Scott, both Council and Mr. Scott giving possible solutions to the matter. Mr. Bill McGannon also of Oak Avenue was present and commented on the matter. 7210

Councilman Humphreys stated he would like to commend Mr. Scott for going to people regarding throwing of bottles.

The City Manager advised Council of the status of water condition and recommended to Council that water consumption ordinance be left in effect at the present time. He also advised that State Water Control Board had said the raw water supply was inadequate and also filter water supply. He stated there might be funds to help this situation. 7211

On motion by Roy Roberts, seconded by Jim Humphreys and carried by unanimous roll call vote Council moved that upon the recommendation of the City Auditor that investment funds in the amount of \$20,867.15 be de-obligated as outlined on attached sheet (Page 196). 7212

The City Manager presented request from Planning District I Community Mental Health and Mental Retardation Services Board for the City of Norton to deposit with their Fiscal Agent, County of Wise, \$1,043.42, the proportionate share toward construction costs of the proposed mental health clinic and two satellite centers.

On Motion by Roy Roberts, seconded by Jim Humphreys and carried by unanimous roll call vote Council moved that the amount of \$1,043.42 be paid to Fiscal Agent of Chapter 10 Board.

The City Manager advised Council that Neighborhood Facilities Project Plans have been approved by the Dept. of HUD and that there will be advertising for bids on the Swimming Pool on November 11th at 2:30 P.M.

On motion by Jim Humphreys, seconded by Roy Roberts and carried by unanimous vote Council ratified the list of officers as presented by the Norton Fire Dept. President, B. L. Stough; V. President, Gerald Lawson; Secretary, James Campbell; Treasurer, Joe Fischer.
