

The regular meeting of the City Council was held in the Municipal Court Room on April 3, 1973 at 7:30 P.M. with Vice Mayor Fulks presiding.

Also Present: Milas Franks, City Manager & Montie Meeks, Attorney

Absent: Archie V. Woods

Minutes of the previous meeting were read and approved.

The Clerk read letter of resignation of Archie V. Woods, Mayor & Member of Norton City Council. 6261

Mr. Dean Graybeal appeared before council on behalf of Big Stone Chamber of Commerce and Virginia Travel Council. He presented brochures of booth of Virginia Nature Lovers to be used at different sections of the country which will show the many different things of interest in Virginia. He requested that the City of Norton contribute \$100.00 toward helping defray the cost of booth. 6262

On motion by W.F. McElroy, seconded by Robert Leonard and carried by unanimous roll call vote council moved that the City donate \$100.00 from contingency to help defray the cost of booth. 6263

Mr. Graybeal also asked if the City would be interested in a membership in the Virginia Travel council. This matter deferred until it would be determined what the Annual Dues were. 6264

Mr. Bill Farmer appeared before council requesting something to be done to the holes in road at Ridge & 11th Street. Matter referred to City Manager. 6265

Mr. Steve Collins appeared before council and discussed with them traffic problem on Federal Street. Mr Collins was advised that the City Manager & Chief of Police would try to work something out on this matter which would be satisfactory to all concerned. 6266

Mr. Franks advised council that the Highway Department had agreed to leave the Grade Separation at 4th Street, as proposed in the City Thoroughfare Plan. 6267

On motion by Jim Humphreys, seconded by W.F. McElroy and carried by unanimous vote council moved that the twice weekly garbage collection begin May 15th thru October 12th. 6268

The City Manager discussed with council water & sewer rates for trailer lot connections. Council instructed the City Manager to study this matter further and then come back to council with suggestion for changes. 6269

Mr. Franks discussed tax on Trailers. Council instructed the City Manager to study this matter with Commissioner of Revenue and come back to council with recommendation. 6270

Mr. Franks presented council with old and proposed personnel policy, for study. He asked that council have a work-study session on this matter. 6271

Mr. Franks discussed with council possibility of acquiring personal liability insurance. 6272

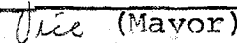

On motion by Jim Humphreys, seconded by W.F. McElroy and carried by unanimous vote council moved that W.P. Kanto be reappointed as member of Duffield Industrial Development Authority for a term of 3 years, said term to expire June 30, 1976. 6274
