

The regular meeting of the City Council was held in the Municipal Court Room on February 3, 1970 at 7:30 P.M. with Mayor Flanary presiding.

Present: V.O. Flanary, G.E. Hunnicutt, S.H. Neeley, W.G. Stallard, Robert Leonard.

Also Present: Evan Norton, City Manager

Minutes of the previous meeting were read and approved.

Mr. Norton read letter from City Manager of City of Wyoming expressing their appreciation for the gift of apples from Wise County. 5059

Mr. Norton read letter from Mr. Frank Russell regarding TV Cable Service. 5060

Mr. Norton advised council of letter he had received from State Board of Education acknowledging resolution from City Council regarding proposed elementary school. 5061

Mr. Norton read letter from Norton Fire Department regarding radio program they were having on February 14th. 5062

Mr. Norton advised council there was no further progress on annexation. 5063

Mr. Norton discussed with council status of EDA and FHA Projects. 5064

Mr. Norton advised council that representatives from Philadelphia Public Housing Office would be here February 4th and would be speaking with representatives over county at Wise Thursday night regarding public housing for the county. He also advised they were to meet with city housing officials on Thursday, Feb. 5th. Council discussed this matter with Mr. Norton. 5065

On motion by G.E. Hunnicutt, seconded by S.H. Neeley and carried by unanimous vote council authorized the city manager to attend the county meeting with public housing officials and attempt to work out some feasible method to help the people of the county to get public housing if they want any help.

Council discussed at length U.S. 23 location.

On motion by G.E. Hunnicutt, seconded by V.O. Flanary and carried by unanimous vote, council moved that City Council petition Highway Commission to go back to the proposition of building 58A from the intersection of 23 and 58A eastward to the east corporate limits of Norton giving sufficient access to permit the said development of the single substantial developmental area remaining in the City of Norton. 5066

On motion by Robert Leonard, seconded by W.G. Stallard and carried by unanimous vote council moved that in view of the fact the City of Norton has plans and have already received proposals to construct public housing on old CCC Camp Site on Lost Creek there be an access road constructed from Kentucky Avenue to that site. 5067



On motion by S.H. Neeley, seconded by G.E. Hunnicutt and carried by unanimous vote council moved that the City of Norton join Wise County in their request to merge Lee County Community Action Agency and Aware, Inc. 5069


