

August 2, 1966

The regular meeting of the City Council was held in the Municipal Court Room on August 2, 1966, at 7:30 P.M. with Mayor Holcomb presiding.

Present: J.C. Holcomb, V.O. Flanary, C.W. Bryant, R.L. Collins

Also Present: David B. Norman, City Manager & Leslie Mullins, Attorney

Minutes of the previous meeting were read and approved.

Mr. Charlie Daniels, Chairman of the City of Norton Planning & Zoning Commission, presented recommendation of the Planning Commission to deny the request of the Coca Cola Company to rezone Lots 11 and 12 in Block 20 from B Residential to General Business. Council agreed to abide by this recommendation. #3721

Mr. Leslie Mullins, City Attorney, presented proposed Building, Plumbing & Electrical Codes for the City of Norton. #3722

On motion by C.W. Bryant, seconded by V.O. Flanary and carried by unanimous vote, the Building Code, consisting of Building Code, Electrical Code and Plumbing Code, were passed on first reading.

Mr. Norman asked Council's permission to have air conditioning installed in the main office. He advised them it would cost approximately \$150.00. Council granted permission for air conditioning to be installed in the main office. #3723

Mr. Norman presented Fall Program for Plant Mix Street Paving. After brief discussion Council approved this program. #3724

Council discussed the placing of base stone on the upper end of Chestnut Street. Council agreed for the City to put the base stone down on Chestnut Street to Highland, and Mr. Cooper is to make a nice intersection and take care of the drainage situation, except drainage from other properties. #3725

Mr. Norman recommended to Council that when curb and gutter is installed from Craig Street to Chestnut Street in vicinity of V.J. Strength's, that curb and gutter be tied in with Chestnut Street. #3726

On motion by C.W. Bryant, seconded by R.L. Collins and carried by unanimous vote, Council moved that Walnut Street North of the intersection of Walnut Street and Fleming Avenue be vacated. #3727

Mr. Norman advised Council that during a recent meeting of the Planning Commission a discussion of Comprehensive Community Planning was held. The Commission recommended to adopt proposed program which is made by the Division of Industrial Development and Planning Commission. #3728

On motion by R.L. Collins, seconded by C.W. Bryant and carried by unanimous vote, Council accepted the recommendation of the Planning Commission to adopt the proposed program of the Division Industrial Development and Planning Commission.

On motion by J.C. Holcomb, seconded by R.L. Collins and carried by unanimous vote, Council reappointed Charlie Daniels as member of Norton Planning & Zoning Commission for a term of three years, said term to expire July 31, 1969. #3729

The City Attorney brought to Council's attention notices of suit against City by Miss Lennie Blankenship. #3730

Mr. Norman advised Council of the arrangement with City of Norton School Board for uniformed policemen to drive City School Buses. #3731

Mr. Norman advised Council of the reduction in price of stone #3732

Mr. Norman advised Council of the status of paving of the School Lot. #3733

Mr. Norman advised Council that street marking has been completed. #3734


Mr. Norman advised Council that the City is still having sewer problems in vicinity of St. Mary's Hospital and that the City is continuing to check this out. #3735

Mr. Norman advised Council of the current paving program. #3736


Mr. Norman advised Council of meeting with George Wharton regarding City Dump. He stated that Mr. Wharton agreed for the City to continue use of Dump with the City doing a little more work on the Dump and the City keeping the road in better condition. Council instructed the City Manager to look into the possibility of moving City Dump to a location in Josephine section owned by the Wise Coal & Coke Company. #3737

Mr. Norman advised Council that a committee from the Chamber of Commerce would be present at next Council Meeting regarding Community College in this area. #3738
