

June 5, 1956

The regular meeting of the City Council was held on the above date in the Municipal Court Room at 7:30 P. M. with Mayor B. E. Ball presiding.

All members of council were present except Sol Cury and answered to roll call.

Minutes of the last meeting were read and approved.

On motion by Fred King, seconded by A. O. Umstead and carried by a vote of those present, the Mayor was instructed to appoint a committee to represent Norton in the tax study commission hearings in Bristol on June 20th. #762

On motion by A. O. Umstead, seconded by Fred H. King and carried by vote of those present, the application for a taxi drivers permit of James H. Collins was denied. #763

On motion by A. O. Umstead, seconded by Fred King and carried by unanimous vote of those present, the following resolution was placed on first reading: #764

BE IT RESOLVED that the following schedule of charges shall be paid by applicants for the improvement requested, and that each such request shall be made in writing to the City Council for its approval.

BE IT FURTHER RESOLVED that the location or the size of said improvement shall be determined by the City Manager, and that any such improvement shall be done at the convenience of the City forces. In the event that City forces are unable to accomodate a request for improvement of the foregoing nature, the improvement made may be constructed the the petitioner at his own expense, provided plans and specifications are approved by the City Council.

- A. Water Lines  
one half dollar per foot, per abutting property owner.
- B. Sewer Lines  
one half dollar per foot per abutting property owner.
- C. Sidewalks  
twenty cents per square foot.
- D. Driveways  
forty cents per square foot.
- E. Curb & Gutter  
cost to borne by City.
- F. Streets  
one and one half dollars per front foot per abutting property owner.
- G. Alleys  
one half dollar per lineal foot per abutting property owner.
- H. Retaining Walls and Steps  
When it becomes necessary through new construction on an old street, retaining walls, and steps will be built or replaced at the City's expense. On new construction, however, these improvements shall be installed by the owner of the property in question.

On motion by A. O. Umstead, seconded by Fred King and carried by vote of those present, the City Council as a committee was to view the proposed sub-division east of Spout Springs and submit a report at the next council meeting. #765

On motion by Fred King, seconded by W. R. Hamner and carried by vote of those present, Mr. Frank Jones was reappointed as a member of the School Board for a term of three years, ending June 30, 1959. #766

On motion by A. O. Umstead, seconded by Fred King, and carried by unanimous vote of those present, Mr. R. A. Sult was reappointed as a member of the Board of Welfare for a term of three years. #767

On motion by W. R. Hamner, seconded by A. O. Umstead and carried by unanimous vote of those present, the request of Herbert Phelps to sell beer on-off premises at the Norton Restaurant was approved. #768

On motion by Fred King, seconded by A. O. Umstead and carried by a vote of those present, the City Manager was authorized to surface treat the area requested by the Catholic Church. #769

On motion by Fred King, seconded by A. O. Umstead and carried by unanimous roll call vote of those present, the City Treasurer was authorized to pay James Price, Registrar, \$35.80 as submitted by his statement plus 2¢ per letter for letters written with the purpose of purging the present registration books. #770


On motion by A. O. Umstead and seconded by W. R. Hamner and carried by unanimous roll call vote of those present, the following resolution was adopted: #771

RESOLVED that the City Board of Public Welfare shall be paid \$10.00 per month with the provision that their attendance is recorded at least one meeting per month and that said annual payments shall not exceed \$120.00

Kenneth Kibler appeared requesting the City support in some manner the soft ball program that had been scheduled with the Church leagues. After a lengthy discussion Mr. Kibler was given two alternatives to work upon and bring back a report to council at a later date. #772

On motion by Fred King, seconded by A. O. Umstead, the following ordinance was placed on first reading: "Subdivision Ordinance for the City of Norton" Said ordinance to be reviewed by the City Council at a meeting for a minimum duration of one and one-half hours prior to the next council meeting. #773
