Also Present: Fred L. Ramey, Assistant City Manager, and Bill Bradshaw, City Attorney.

The Assistant City Manager opened the floor for nominations of Mayor of the City.

Jack Wallace nominated B. Robert Raines to be reappointed as Mayor.

Upon a motion by William Mays, seconded by Joseph Hunnicutt, and passed by unanimous vote, Council moved that the nominations cease.

Mr. Ramey declared Mr. Raines reappointed Mayor of the City of Norton and asked Mr. Raines to come forward and be sworn in by the Clerk. Following being sworn in, Mayor Raines then took his seat on Council.


