

An organizational meeting of the Norton City Council was held at 7:00 p.m. on Tuesday, July 7, 1992, with City Manager E. W. Ward presiding.

Present: Linda Sturgill, Jack Wallace, Robert Raines, William Mays, and Ron McCall

Also Present: E. W. Ward, City Manager

Mr. Ward opened the floor for nominations of Mayor of the City of Norton. William Mays nominated Robert Raines.

Upon a motion by Jack Wallace, seconded by Linda Sturgill, and passed by unanimous vote, Council moved that the nominations cease. 15416

Mr. Ward declared Mr. Raines reappointed as Mayor and asked Mr. Raines to come forward, be sworn in by the Clerk, and take his seat on Council.

Mayor Raines opened the floor for nominations of Vice Mayor of the City of Norton.

Jack Wallace nominated William Mays.

Upon a motion by Ron McCall, seconded by Linda Sturgill, and passed by unanimous vote, Council moved that the nominations cease.

Upon a motion by William Mays, seconded by Jack Wallace, and passed by unanimous vote, Council moved that the nominations cease. 15418

Mayor Raines declared Mr. Ward reappointed as City Manager.

The Mayor opened the floor for nominations of City Clerk.

Ron McCall nominated Mary Brown.

Upon a motion by Jack Wallace, seconded by William Mays, and passed by unanimous vote, Council moved that the nominations cease. 15419

Mayor Raines declared Mary Brown reappointed as City Clerk.

The Mayor opened the floor for nominations of City Attorney.




There being no further business to be conducted during this organizational meeting, the meeting was adjourned.
