

The regular meeting of the City Council was held in the Council Chambers on September 15, 1987 at 7:30 P.M. with Mayor Daniels presiding.

The Invocation was given by Rev. Warren Stewart, followed with Pledge of Allegiance led by Glenn Teasley. 13921

On motion by Jack Wallace, seconded by Roy Roberts and carried by unanimous vote, Council moved that minutes of Sept. 1, 1987 be approved as presented. 13922

The Mayor called for audience for visitors - No response. 13923

Public Hearing on "An Ordinance of the City Council of the City of Norton, Virginia, Amending the Flood Plain Zoning Ordinance Heretofore Adopted in January of 1987, Providing for the Exemption of Manufactured Homes Placed in Existing Mobile Home Parks to Special Flood Hazard Areas Pursuant to 44 C.F.R., Parts 59 & 60."

Discussion of Water Reserves - Mayor Daniels presented report from City Manager on water in reservoirs. He advised as of 10:30 A.M. on this date there was 80.3 million gallons of water which was only three days supply less than Sept. 1. He again ask that citizens begin to conserve water. 13928

Comments by City Manager - Mr. Brown advised of conference to be held on Oct. 13th & 14th on first draft of recondification of Code with the Municipal Code Corporation. 13929

The Mayor advised council had received in their packet a five year capital plan. As agreed upon before, he suggested council review these plans and present comments to City Manager for review at an October meeting.
