

The regular meeting of the City Council was held in the Municipal Court Room on February 7, 1984 at 7:30 P.M, with Mayor Hunnicutt presiding,

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that minutes of January 17th, January 30th and January 31st be approved as presented.

Discussion of Water Reserves. Mr. Brown brought council up-to-date on water situation stating that as of Feb. 2nd there was 72.45 million gallons of water in combination of the two reservoirs. Council briefly discussed this matter.

On motion by Roy Roberts, seconded by W.F. McElroy and carried by unanimous vote, Council moved to rescind the emergency water ordinance passed on October 14, 1983.

Discussion of Joint meeting with the Planning Commission to Review the proposed Site Plan Ordinance.

Council agreed to have this meeting on February 27th at 7:00 P.M.

An Ordinance of the City Council of the City of Norton, Virginia Amending Section 6-22 of the Norton City Code to Provide that Any Citizen Eighteen Years of Age shall be eligible for membership in the Fire Department.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that the Ordinance Amending Section 6-22 of the Norton City Code be passed on second reading.

Discussion of Portable Sign Provision in the Comprehensive Sign Ordinance of the City of Norton, Virginia.

The City Manager brought council up-to-date on this matter.

On motion by Cliff Daniels, seconded by Vic Jones and carried by the following votes: McElroy, Hunnicutt, Jones, Daniels, YES; Roberts, NO, Council moved to extend forty-five (45) days enforcement of comprehensive portable sign ordinance.

Mr. Brown introduced the new Chief of Police, Mr. Samuel A. Mongle, and advised of his beginning date of employment with the City.

Request for \$26.96, said fund to come from contingency to pay the City of Norton portion of the Southern Engineering bill.

On motion by W.F. McElroy, seconded by Vic Jones and carried by unanimous roll call vote, Council moved that pay \$26.96 to Southern Engineering Company, said funds to come from contingency.

Request for \$330.58 to pay City Attorney for services in the Old Dominion Power Company Case.

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous roll call vote, Council moved to pay \$330.58 to Kenneth P. Asbury, City Attorney for services in the Old Dominion Power Company Case, said funds to come from contingency.

Discussion of an Ordinance of the City of Norton, Virginia interpreting and Declaring the intent of the Ordinance Prohibiting Parking More than Two Hours in any Parking Space so marked in the City of Norton, Virginia. Council briefly discussed this matter. No action was taken on this ordinance.

On motion by Vic Jones, seconded by W.F.McElroy and carried by unanimous vote, Council moved they go into executive session to discuss personnel as per 2.1-344 (A) (1) and Legal Matters as Per 2.1-344 (A) (6) of the Code of Virginia, as Amended. 11133

On motion by Vic Jones, seconded by Cliff Daniels and carried by unanimous vote, Council moved that they go back into regular session.


The Mayor declared council back in regular session.


