

The regular meeting of the City Council was held in the Municipal Court Room on October 5, 1982 at 7:30 P.M. with Mayor Hunnicutt presiding.

Present: George Hunnicutt, W.F. McElroy, Cliff Daniels, Vic Jones

Also Present: C.R. Brown, City Manager & Kenneth Asbury, Attorney

On motion by Cliff Daniels, seconded by Vic Jones and carried by unanimous vote, Council moved that minutes of Sept. 21, 1982 be approved as presented. 10643

Linda Jones, a resident from Dorchester Road on left side across from Century Trailer Court, appeared before council regarding water damage caused by improper drainage. She stated the City & State had acquired an easement from her but had failed to keep their agreement to fix sewer line and water drainage problem. The City Manager assured her he would come and check this matter out this week. 10644

Mr. Don Earles addressed council in behalf of Morris Burchette, Glenn Hill, Howard Calloway, Ray Hamm, inquiring as to plans for 700 block with regard to storm drainage. He stated since they were working on 900 block now, they were concerned as to what was going to be done in 700 block to eliminate flooding of their businesses. 10645

Glenn Hill also spoke on this matter. Council discussed this at length with these citizens.

The City Manager presented plans he had for this block and also the continuation in the 900 block. He also advised of plans for drainage in section near railroad tracks at Route 74 and back of Piggly Wiggly in the Plaza.

Consideration of the Comprehensive Plan of the City of Norton as prepared by Balzer and Associates.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved that the following Resolution "Of the City Council of the City of Norton, Virginia Adopting and Approving Updated Amendments of the City of Norton Comprehensive Plans" be passed (Insert) 1064

Nomination of Mountain Empire Older Citizens, Inc. to Respond as Lead Agent in Planning District One for Long Term Care as per Senate Bill 219.

On motion by W.F. McElroy, seconded by Cliff Daniels and carried by unanimous vote, Council moved that Nomination of Mountain Empire Older Citizens, Inc. to Respond as Lead Agent in Planning District One for Long Term Care as per Senate Bill 219 be passed. 1064

Roof Repairs over Council Chambers: Mr. Brown brought council up-to-date on status of roof repair to City Court Room with respect to bids as presented at last council meeting. 1064

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous roll call vote, Council moved that accept bid of Abingdon Roofing Company in sum of \$4500.00, with ten year guarantee for flat roof, said funds to come from prior year's surplus, if any.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved they go into executive session to discuss pending legal action. 1064

On motion by Vic Jones, seconded by W.F. McElroy and carried by unanimous vote, Council moved they go back into regular session. 1065

Mayor Hunnicutt declared council back in regular session.

Mayor Hunnicutt reported that with respect to pending litigation they had decided the City of Norton would withdraw any cause of action against Jim Brown and Paramount Land Company.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved that the following be passed:

Be It Resolved that the City of Norton accept the sewer line as shown in the deed of Paramount Land Company, recorded in the Clerk's Office at Wise- Resolution to be drawn up by City Attorney & attached as part of minutes. 10651

Council briefly discussed connection for Rose's Store and City Manager gave his recommendation.

On motion by W.F. McElroy, seconded by Vic Jones and carried by unanimous vote, Council moved that Mr. Don Earles and Mr. Charlie Brown get together with Mr. B.J. Allison and his attorney and work out an agreement that is satisfactory to both parties with the constraint that no one else basically hooks up except Roses and then and thereupon and subject to the approval of City Manager Brown and the Special Attorney, Don Earles, then and thereupon we agree to permit ten (10) equivalent hookups. 10652

Payment to Wiley & Wilson for services through August 31, 1982 in the amount of \$2,532.12. The City Manager discussed this matter with council. Council directed the City Manager to get more information on this payment request with regard to complete total for August, said information to be brought back to next council meeting. 10653

Request by the Copper Kettle for five (5) equivalent sewer connections outside of the City of Norton. 10654

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous vote, Council moved that the Copper Kettle be granted five (5) equivalent hookups subject to the approval of the State Water Control Board and the Administrative Approval of the City of Norton. 10651

The City Manager presented bids for new truck, financed by Revenue Sharing for Solid Waste. Council discussed this matter with the City Manager. 10651

Councilman Daniels requested these bids be carried over until next council meeting. Council was in agreement for this to be done. 10651

Mr. Brown advised council that T.V.A. had been contacted and they were willing to give us any assistance that we need. He also advised they were sending someone here within a week to assist in weir gauge at different water sites. 10651

Mr. Brown advised council that W. & L. were not going to be able to pave for City until spring of 1983, at which time the bid price will still be the same. 1065

Replacement of G.M. Newman on Welfare Board. Council agreed for this to be carried over until next meeting and for names to be presented. 1065

Appointment of prosecuting attorney delayed until later date. 1065


Council inquired of City Manager status of street painting. 1066
