

The regular meeting of the City Council was held in the Municipal Court Room on November 5, 1980 with Mayor Hunnicutt presiding.

On motion by Robert Collier, seconded by W.F. McElroy and carried by unanimous vote, Council moved that minutes of previous meeting be approved as presented.

Mr. Ron Workman of Planning & Design Associates appeared before council and presented revised alternatives for the Norton Revitalization Plans. Mr. Workman went over each of the alternatives with council. Council discussed this matter at length.

On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous roll call vote, Council moved that accept Alternate #3 with eye toward #2 and authorize the City Manager to proceed with final plans of this 3rd Alternate.

Mr. Prior ask council if it was their desire for Mr. Dawson and himself to continue on with the paper work as relates to acquisition on this property. Council briefly discussed this matter.

On motion by W.F. McElroy, seconded by Robert Collier and carried by unanimous vote, council moved that "An Ordinance Repealing an Ordinance adopting a Contingency Plan for the use of Water During Periods when the City of Norton is Experiencing a Water Shortage" was passed on second reading. On motion by W.F. McElroy, seconded by Robert Collier and carried by unanimous vote, Council moved that An Ordinance adopting a Contingency Plan for Controlled Use of water during water shortage in the City of Norton, Virginia was passed on seconded reading." (Insert)

Mr. Newman advised council that all three bids for dump trucks were out because of sale of trucks.

Council discussed additional removal of soil from Upper Reservoir.

On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous roll call vote, council moved that authorize City Manager to spend up to \$31,000.00 out of contingency fund to remove additional dirt up to 10,000 yards from reservoir and tack an additional sum not to exceed \$2,000 to pay for water capacity survey.

On motion by Robert Collier, seconded by Cliff Daniels and carried by unanimous vote, council moved they go into executive session for consideration of personnel matters.


On motion by Cliff Daniels, seconded by Robert Collier and carried by unanimous vote, council moved they go back into regular session.


