The regular meeting of the City Council was held in the Municipal Court Room on November 7, 1979, at 7:30 P.M. with Mayor Hunnicutt presiding. Present: George Hunnicutt, W.F. McElroy, Robert Collier, Cliff Daniels, Frank Fischer Also Present: G.M. Newman, City Manager and Kenneth Asbury, Attorney On motion by Cliff Daniels, seconded by Frank Fischer and carried by unanimous vote, Council moved that minutes of October 16th and October 30th be adopted by consent. A group of members from Norton Rescue Squad with Jim Hill as spokesman appeared before Council requesting funds to help with their building program. Council discussed this matter briefly. On motion by Cliff Daniels, seconded by W.F. McElroy and carried by unanimous roll call vote, Council moved that \$3,400.00 surplus in Revenue Sharing Fund be appropriated to Rescue Squad, making a total appropriated of \$10,600.00. Mr. Bill Skeens of Thompson & Litton was present and presented information on million gallon water tank as requested by Council. On motion by Cliff Daniels, seconded by Frank Fischer and carried by unanimous roll call vote, Council moved that pay to Thompson & Litton \$4920.10, a difference between allowance of cost between inspection and supervision of million gallon water tank, this to be full and final settlement of construction, said funds to be paid from Community 9674 Development Funds. Discussion of 201 Sewer Study was tabled until next Council meeting. 9675 On motion by W.F. McElroy, seconded by Robert Collier and carried by the following votes: McElroy, Collier, Daniels, Fischer, YES; Hunnicutt, No, Council moved that accept bid of Stout Construction Company in amount of \$1.00 for demolition of two old school buildings and that City Manager be authorized to enter into contract with said company. 9676 On motion by W.F. McElroy, seconded by Cliff Daniels and carried by unanimous vote, Council moved that City Manager be authorized to execute contract with Department of Highways and Transportation for maintaining bridge on Route 610 Dorchester. 9677 On motion by Cliff Daniels, seconded by Frank Fischer and carried by unanimous vote, Council moved that authorize and direct City Manager to draw down requests and to be co-signer of checks for CDBG and that resolution be sent to Treasury Department advising 9678 On motion by Robert Collier, seconded by Frank Fischer and carried by unanimous roll call vote, Council moved that accept deed to two parcels of land in S.S. Development by Norton Redevelopment and Housing Authority. 9679 Mayor Hunnicutt presented Council with letter notifying them of his purchase of property on Park Avenue beginning with Pizza Hut through property where Virginia State

The City Manager gave Council up-date on daily water consumption, second phase of paving, status of tank as to when will be put in service, 4th Street water tank.

On motion by Robert Collier, seconded by Frank Fischer, and carried by unanimous vote, Council moved that Mayor and Clerk be authorized and directed to execute deed to Department of Highways and Transportation for three pieces of property, previously optioned by Department of Highways, said execution of deeds to be upon approval of City Attorney.

There being no further business to come before the Council same adjourned.
