

The regular meeting of the City Council was held in the Municipal Court Room on June 6, 1978 at 7:30 PM with Mayor Fulks presiding.

Present: Ike Fulks, W. F. McElroy, George Hunnicutt, Vernon Flanary, Bill Necessary

Also Present: Joe Baker, City Manager & Kenneth Asbury, Attorney

Minutes of the previous meeting were read and approved.

A group of citizens from the Hootowl section of the City were present and inquired as to reason they would have to pay for city stickers when they had received no benefit from the City. They also asked that a drain line be put in and that the roads be put in passable condition. Council directed the City Manager to try to get road fixed so that they could get in and out and to get ditch line prepared and cleaned out.

Two gentlemen from Sawmill Hollow section of Norton were present at Council meeting and requested something be done to widen road, clean out ditch line and have signal light installed at railroad crossing. Council advised that this street is on the program for paving.

Mr. Bill skeen of Thompson & Litton was present and presented Council with 201 Study. Council discussed this matter at length with Mr. Skeen and directed the City Attorney to prepare resolution for Council's consideration at next Council meeting.

Mayor Fulks asked the City Manager if he had found out the trouble with Lost Creek Water. The Manager advised the street cleaning truck was getting water from another section.

Mayor Fulks inquired as to status on new water tank. The City Manager brought council up-to-date on the water project.

Councilman Flanary brought to City Manager's attention the request of Claude Adams regarding water to Adam trailer park, He stated Mr. Adams was of the opinion that installation of pump by the City had caused his water pressure to go down by being drawn out of his lines.

Councilman Hunnicutt inquired of the City Manager findings of water running on to Virginia Avenue between 8th and 9th street. The City Manager stated it was definitely not sewer nor was it water from City water system.

Councilman Flanary presented request of R. C. Hubbard of Craig Street regarding racing on Craig Street. Council discussed briefly stop signs at intersection of Hagan and Chestnut Streets. This was in connection with Craig Street speeding.

Mayor Fulks announced it was now time for Public Hearing on proposed Budget for 1978-1979 as advertised. The City Manager went over the entire Budget with Council. Persons from audience speaking on or asking questions on Budget were Monroe Thrower, George Scott, George Lewis, Robert Collier, and Cliff Daniels.

On motion by Bill Necessary, seconded by W. F. McElroy and carried by unanimous roll call vote council moved that John Krulis be appointed to the Family Oriented Home Board of Directors to fill the vacancy created by Mrs. Robert Winston.

The City Manager presented request of Piggly Wiggly Company for refund of wholesale merchants license for last quarter. Matter tabled for further investigation.

The City Manager advised Council there would be a Public Hearing on rezoning request on Thursday at 7:00 PM.

There being no further business to come before the Council, same adjourned.
